





Duplicate Payments

Why

Avoiding payments on not wanted invoices & saving large amounts of money but especially efforts/rework

- Same invoice NOT paid twice
- How
 - Process mining model to provide insights
 - QPR Duplicate Payment Dashboards

Automation

Why

- Minimizing manual efforts where not needed
 - = > AP Resources can be focused on value adding topics

- **RPA/Workflow** automation for operations
- How
 - Process mining model to provide insights
 - QPR Automation Dashboards

Why

Minimizing maverick purchasing & increasing compliance

- Driving usage of POs (not just late POs)
- How
 - Process mining model to provide insights
 - QPR PO Penetration Dashboards



Invoice Processing Lead times

Why

 Having agile & mature AP process where BPI makes impact

- Less process deviations (and variations!)


